Connected transaction concerning goods or services providing labor, human resources for any assigned positions and/or as specified by the Hirer for purpose of business benefit of the Hirer and preparing engineering report (Fact-finding Report).

4. Transaction Value

The Hirer agrees to pay and the Contractor agrees to receive service fee not exceeding 5,000,000 Baht (Five Million Baht) per annum (VAT Excluded), detailed as specified in attachment of the contract and shall be considered as part of the contract. Payment shall be made by cheque paid to the Contractor within 30 days.

Condition of the Transaction

Considered as a connected transaction concerning goods or services. The size of the transaction is classified as a medium sized transaction, worth higher than 1 million Baht but less than 20 million Baht or a value greater than 0.03 percent but less than 3 percent of the Net Tangible Asset (NTA) of the company.

6. Opinion of the Board of Directors / Expected Benefit

- 6.1 The Human Resources and Engineering Services Contract clearly states service fees in its attachment. The service fees are based on cost plus profit, so it is deemed that the Company shall not lose its economic benefit.
- 6.2 The Human Resources and Engineering Services Contract allows a linkage between the Company's Hot Rolled Coil Business and the Hirer's Hot Rolled Plate Business, so that the expected benefits are as follows:
  - 6.2.1 New market access for the Company,
  - 6.2.2 Operational co-operation between the Company's Hot Rolled Coil Business and Sahaviriya Plate Mill Public Company Limited, and
  - 6.2.3 New market opportunities for the both companies.
