On 29 January 2018, the Board of Directors' Meeting No. 2/2018 of Sahaviriya Steel Industries Public Company Limited, as the Plan Administrator by the Central Bankruptcy Court's order, passed the following significant resolutions:

- 1. Acknowledged that Mr. Wit Viriyaprapaikit has vacated his position as Chairman of the Board of Directors and Director of the Company.
- 2. Acknowledged the resignation of Mr. Somchai Sakulsurarat from the position of Deputy Chairman of the Board of Directors, effective from 28 January 2018, but shall remain his position as a Director, Independent Director and Chairman of the Audit Committee.
- 3. Elected Mr. Somchai Sakulsurarat, Independent Director and Chairman of the Audit Committee, as Chairman of the Board of Directors effective from the Board of Directors' approval onward.
- 4. Approved the amendment of the power of directors as follows: Names and number of the authorized directors of the Company are "Mr. Kamol Juntima or Mr. Somchai Pipitvijitkorn or Mr. Win Viriyaprapaikit or Mr. Nava Chantanasurakon, any two of four directors jointly sign with the Company's seal affix.

For the vacation of the Director and the amendment of the power of directors stated in clause 1 and 4 above, the Company, as the Plan Administrator by the Central Bankruptcy Court's order, shall file a petition with the Central Bankruptcy Court for an order approving the change of director and change of names and number of the authorized directors in order that the registrar of Public Limited Company, Department of Business Development, Ministry of Commerce, accepts the registration of such changes afterward.
