Clause 7.3(3) of the business rehabilitation plan provides that the Company is required to register the increase in its paid-up registered capital by THB 10,000,000,000 by issuing an additional 10,000,000,000 newly-issued ordinary shares to accommodate the conversion of debt into equity in favor of the second group of creditors, and/or the third group of creditors, and/or the fourth group of creditors at the price of the conversion of debt into equity of THB 0.05 per share.

The Company hereby announces that the Company has registered the increase in paid-up capital in an amount of THB 10,000,000,000 with the Ministry of Commerce on 28 March 2018, and at present, the Company's paid-up capital has been changed from THB 1,113,018,280 to THB 11,113,018,280. dividing into 11,113,018,280 ordinary shares at the par value of THB 1 per share. The Company has the registered capital of THB 11,113,018,280. Please be informed accordingly.

In addition, the conversion of debt into equity in favor of the group of creditors mentioned earlier resulted in a change of major shareholding structure of the Company. The summary of major shareholders as at 26 March 2018 is as shown follows:
