Remarks:

- The right to attend to the Program is not transferable to any other person. However, a non-individual shareholder may appoint one designated individual to attend the Program.
- In case of inability to attend the Program, the Attending Shareholders shall notice the Company no less than 7 days prior to the date of the Program so that the Company can replace the vacancy by other shareholders.
- The Attending Shareholders with health concerns should not accept an invitation, for their own wellness.
- Due to the care for health and safety of all visiting shareholders, the Company shall request shareholders to strictly follow safety guidelines or instructions from our staff. In an occurrence of any incident caused by visitors not following our safety guideline or instructions, the Company shall not be held responsible for such incident.
- The Program may be cancelled or postponed at any time. In such event, the Company will try to contact all Attending Shareholders; but shall not be held responsible if any Attending Shareholder cannot be contacted within a reasonable time.
- The Company may depart on schedule without waiting for any Attending Shareholders who cannot show up on time.
- Decision of the Company shall be final.

- Please kindly note that visiting hot strip mill required to wear closed-toe and closed heel shoes, socks and long pants.

2. For non-individual shareholders: Type SSI followed by space, name of shareholder followed by space, first name and last name of an appointed person on a mobile phone, and send to number 4139112.

Example of a message: SSI ABC Company Manee Meeta

Conditions

The Company reserves the right to determine qualifications of eligible shareholders to attend the Program based on following criteria:

- Shareholders must submit their intention to the Company as explained above during 15 July 2015 - 15 September 2015, and must have their names shown on the share register book on 30 March 2015 being the date of determining the names of shareholders entitled to attend the 26th Annual General Meeting of Shareholders. Only those who meet these all requirements specified in this document will be randomly selected to be an attending shareholder.
- Shareholders submitting their intention will be charged 3 Baht per one message sent. Each shareholder will get one right to be randomly selected. Additional messages will not create additional rights.
- Submission procedure for the Program will be complete only after receiving the message **"Your submission for SSI's Site Visit Program is complete"** from the Company.
- Shareholders who have been on a site visit before shall be no longer eligible to attend the Program again, and the Company will give priority to those who have never been on a site visit first.
